### PAYMENT OPTIONS

Annual\*, quarterly, monthly, fortnightly, weekly.

\*A 2% discount is applicable for annual payments made before 16 January.

### Fees

It is a condition of entry into the College that fees are paid via the direct debit facility (with the exception of annual payment in advance option).

### Sibling discount

Fee discounts apply for the third, fourth and subsequent children provided the students are attending Beaconhills College concurrently.

### Annual fee payment in advance

A discount of 2% is available to families who wish to pay one full year's total tuition fee account and capital levy in advance (inclusive of the total of all student charges listed on your account).

### Capital levy

The capital levy is a \$1020 per family annual compulsory contribution, which is non-tax deductible.

### Parental assistance

The parental assistance levy of \$240 is charged to the fee tuition account in conjunction with the capital levy. Should parents prefer to participate in College activities or donate goods and services, the College will provide a credit for the amount charged on the fee tuition account.

### Endowment

It is a condition of entry that each family pays an endowment fee of \$800 before the first child in the family attends the College.

### Application fee

A non-refundable application fee (AUD \$100) is payable at the time of lodging an application for a place at the school.

### Placement and administration charge

AUD \$250 (non-refundable).

### Placement acceptance

When a place is offered, parents are required to pay six months tuition fees and the full visa-length student health cover payment\* within 30 days.

Where in-country visa application procedures prohibit this, the referring agent may apply in writing to the Head of Admissions for an extension to this date.

*\*International students studying in Australia are required to be covered by health insurance as a safeguard against medical costs during the extent of their stay in Australia. Payment details will be provided upon application.*

### Payment of fees and charges

Accounts for fees will be issued twice a year. Fees are subject to annual increases. Payment is

strictly 30 days from the date of the invoice. Fees can be paid by bank transfer or credit card. Cash payments are not accepted.

*\* A discount of 2% is available to families who wish to pay one full year's tuition fee.*

### Other costs

The following costs are approximations only and provided for budgetary purposes:

- books and stationery items AUD \$300 pa, plus GST
- iPads are compulsory items for Years 3-8
- Senior School students (Years 9 – 12) are able to bring their own computing device to school. We recommend laptops for senior students although iPads are permitted
- school uniform AUD \$850, plus GST.

### Goods and Services Tax (GST)

GST is not charged on school fees and co-curricular activities. Other activities, however, may attract GST. School costs and charges have been calculated on the basis that they are GST free.

## TUITION FEES

Tuition Plus fees listed are for students studying on a Student visa (Subclass 500). Tuition fees do not include health insurance, uniform, accommodation or living expenses while studying in Australia.

### Charges

Students are expected to return home during the mid-year and end of year semester breaks. Boarding accommodation fees are for term time only. Boarding students wishing to stay in Australia during the term 1 and term 3 breaks can apply for homestay and will be charged additional accommodation fees at the current homestay rate.

AUD \$500 refundable bond, providing accommodation is left clean, tidy and undamaged.

### Airport pick-up

Full details of flight arrangements must be provided to the school one week before arrival to ensure that arrangements for your child's pick-up can be made. If there is a change, please advise the school immediately. The cost of the service (subject to market changes) will be charged to the fee account.
